### Actions for Damages – Quantification of Harm

The EC adopted the so-called "Passing-on Guidelines", as foreseen in the Antitrust Damages Directive. These guidelines will assist national courts to estimate the economic harm caused by a cartel.

### ■ Solvency II

The EC published a report on the application of Directive 2009/138/EC on the taking and pursuit of the business of Insurance and Reinsurance (Solvency II) with regard to group supervision and capital management within a group of insurance or reinsurance undertakings.

### ■ EU-Mercosur Trade Agreement

The EU and Mercosur countries (Argentina, Brazil, Paraguay and Uruguay) reached a political agreement on a trade deal, which is part of a comprehensive Association Agreement still under negotiation. The deal will remove the majority of tariffs on EU exports to Mercosur (on industrial products such as cars, machinery, chemicals, clothing, pharmaceuticals, textiles) and also covers a wide range of sectors and sector-specific regulatory provisions in the services (telecommunications, postal and courier services, financial). Now the two parties will perform a legal revision of the text, which will then be translated and submitted to the European Parliament and EU Member States for approval.

### **■ EU-Vietman Trade Agreement**

The representatives of the EU signed the EU-Vietnam Trade and Investment Protection Agreements. Next step is the vote by the European Parliament. The Investment Protection Agreement will also be presented to the national Parliaments of the EU Member States. The European Commission aims at a ratification of the agreements by the coming months.

### **■** Council Presidency

Finland has taken over the rotating Presidency of the Council. During its term, which will end in December, the Country will focus on strengthening the EU's common values and the rule of law, making the EU more competitive and socially inclusive, strengthening the EU's position as a global leader in climate action and protecting the security of citizens.

### **Presidency Programme**

### ■ New European Commission

The nominee to be next Commission President Von der Leyen will be in Brussels next week to meet Parliamentary leaders and the different political groups; she needs the approval of the European Parliament to become the next President of the Commission.

### **■ EU Competition Policy Reform**

The Economy Ministers of Germany, France and Poland presented a joint proposal to amend the European rules on competition in order to adapt them to the current situation and allow European companies to compete at a global level. In particular, the three countries express the need to simplify procedures and introduce more flexibility so to facilitate big mergers in the Union.

### ■■ Connected Cars

The Committee of Permanent Representatives of the Council had another discussion on the highly contested Commission delegated act on Cooperation Intelligent Transport Systems (C-ITS). There are divisions inside the EU institutions and amongst Member States and stakeholders on which technology to choose for the future connectivity of vehicles, either the WiFi networks (as proposed by the Commission) or 5G.
