#### ■ Covid-19 and Mobile Data

The EC adopted a Recommendation with measures to develop a common European approach for the use of mobile applications and mobile data in response to the coronavirus crisis. In the coming weeks the Commission will also provide guidance on data protection and privacy implications. Members States and the Commission shall develop a toolbox by 15 April. Member States shall then report on the actions taken by 31 May.

#### EC recommendation on apps for contact tracing

#### Covid-19 and State Aid

The EC adopted an amended Temporary Framework for State aid measures to support the economy in the current Covid-19 outbreak. It will be in place until the end of December and it foresees:

- more support for coronavirus related research and development;
- more support for the construction and upgrading of testing facilities;
- more support for the production of products relevant to tackle the outbreak;
- targeted support in the form of deferral of tax payments and/or suspensions of employers' social security contributions;
- targeted support in the form of wage subsidies for employees.

## Temporary Framework

#### Antitrust

The EC issued a Temporary Framework to provide guidance to companies cooperating in response to the current coronavirus crisis. In addition to that, the Commission presented Guidelines to optimise supply and availability of medicines during the outbreak.

#### VAT

The EC temporarily waived customs duties and VAT on the import of medical devices and protective equipment from third countries in order to help in the fight against coronavirus.

#### Steel Producers

The EC imposed provisional anti-dumping duties on hot-rolled stainless steel coils and sheets from China, Indonesia and Taiwan.

#### International Trade

The Council agreed its position on amending a regulation concerning the application and enforcement of international trade rules by the EU. The Council can now start negotiations with the European Parliament as soon as the latter has agreed its stance.

#### ■ Medical Devices Regulation

The EC presented its proposal to postpone by one year, until 26 May 2021, the date of application of the Medical Devices Regulation. The proposal now needs to be adopted by both the European Parliament and the Council through an accelerated co-decision procedure.
