■ Data Governance Act

The EC proposed new rules on data governance which aims at facilitating data sharing across the Union and between sectors. In particular, the regulation will create the basis for a new system of data governance in line with the principles of consumer protection and the competition rules. Interested parties can also submit their feedback on the proposal until 22 January. This is only the first step, other measures, including the so-called Data Act, will be released in the coming months in order to reach the Commission's goal of a single market for data, where data can be used safely and fairly for the common good.

■ Action Plan on Intellectual Property

The EC adopted a new Action Plan on Intellectual Property that sets out a series of steps to improve the protection of IP, to improve the enforcement of IP rights and to promote a global level playing field. The plan also seeks to ensure that the European IP framework is fit for the digital age. The Commission intends to work also on an improved copyright infrastructure and to increase transparency and predictability in the licensing of standard-essential patents.

■ Pharmaceutical Strategy

The EC adopted a Pharmaceutical Strategy with the aim to support competitiveness, innovation and sustainability of the European pharmaceutical industry. The strategy includes a series of legislative and non-legislative actions which will be launched over the coming years, including a proposal for the revision of pharmaceutical legislation in 2022.

■ Taxation

The EC published its inception impact assessment on the future revision of the Directive on Administrative Cooperation. Contributions to the document can be submitted until 21 December.

■ Sustainable Finance

The EC launched a consultation on the first two sets of criteria for determining which economic activities can be qualified as environmentally sustainable under the EU's taxonomy. Contributions can be submitted until

18 December. The Commission will then finalise its delegated act, which will be subject to scrutiny by the European Parliament and the Council. The legislation will apply from 1 January 2022.

■ Collective Redress

The European Parliament adopted new rules to strengthen collective redress. In particular, the directive will make collective redress available across the Union, covering a broad range of areas included telecommunications, energy and financial services. The directive will enter into force 20 days after its publication in the EU Official Journal. Member States will have until January 2023 to transpose the new Directive into national law.
