European Green Deal

The EC adopted a series of energy policy proposals for the implementation of the European Green Deal with the aim to achieve climate neutrality by 2050 and emission reduction for 2030.

The 2020 State of the Energy Union Report looks at the different dimensions of the Energy Union such as renewables, energy efficiency and security, the internal energy market, competitiveness and innovation. Together with the report, the Commission released individual assessments of the 27 National Energy and Climate Plans (NECPs), which analyse the pathway and ambition of each Member State.

The Commission also released its strategy for a European Renovation Wave, with the aim to boost renovation rate of buildings focusing in particular on decarbonisation of heating and cooling, tackling energy poverty and renovation of public and worst-performing buildings.

Last but not least, the Commission adopted a strategy to reduce methane emissions in Europe and internationally. The strategy contains legislative and non-legislative actions in the energy, agriculture and waste sectors. In the coming months, the Commission will also review the Effort Sharing Regulation and will consider extending the scope of the Industrial Emissions Directive to cover methane emitting sectors not yet included.

■ Chemicals Strategy

The EC adopted its Chemicals Strategy for Sustainability which sets out concrete actions to make chemicals safe and sustainable. In particular it proposes to ban the most toxic substances by default, authorising them only on a case-by-case basis.

■ New Competition Tool

The EC released a summary of the contributions received to its public consultation on the New Competition Tool, which ended last September. In the dedicated page, the Commission also published the summary of the contributions of the National Competition Authorities and some experts' reports.

■ State Aid Temporary Framework

The EC decided to prolong all sections of the State Aid Temporary Framework for six months until 30 June 2021 and the section to enable recapitalisation support for three months until 30 September 2021. In addition to that, the Commission extended the scope

of the framework adopted last March by enabling Member States to contribute to the fixed costs of companies that are not covered by their revenues and to adapt the conditions for recapitalisation measures. By 30 June 2021, the Commission will assess the need to further prolong or adapt the Framework.

■■ Motor Vehicle Block Exemption Regulation

The EC launched a public consultation on the Motor Vehicle Block Exemption Regulation with the purpose to assess whether and to what extent the objectives are fulfilled. The evaluation will continue until next Spring, then the Commission will decide on the future exemption regime that will apply after May 2023. Contributions can be submitted until 25 January.

■ Artificial Intelligence

Fourteen EU Member States (Denmark, France, Finland, Estonia, Belgium, the Czech Republic, Ireland, Latvia, Luxembourg, the Netherlands, Poland, Portugal, Spain and Sweden) jointly signed a position

paper on the need "to shape a truly European approach on Artificial Intelligence" and to avoid fragmentation from diverse national regulatory regimes. In particular they call on the Commission to adopt a soft law approach consisting of self-

regulation, voluntary labelling scheme and other voluntary practices while avoiding barriers. New measures are expected for early 2021.

Climate

EU leaders postponed any decision on a more stringent emission reduction target for 2030 at their next summit in December.
