■ EU-China Investment Agreement

The EU and China concluded in principle the negotiations for a Comprehensive Agreement on Investment (CAI). The text needs to be legally reviewed and translated before being submitted for approval to the Council and European Parliament. The deal also includes a commitment of both sides to finalise negotiations on investment protection and investment dispute settlement within 2 years of the signature of the CAI.
