## / Law

### ■ EU Single Market

The EC adopted three guidance documents to strengthen the implementation of the rules relating to the free movement of goods and the prevention of national barriers. In particular on the implementation of Regulation 2019/515 on the mutual recognition of goods lawfully marketed in another Member State; on the application of treaty provisions regarding the free movement of goods; and on the implementation of article 4 of the new Market Surveillance Regulation.

### ■ Taxation

The Council approved its position on the proposed directive on the disclosure of income tax information by certain undertakings and branches, the so-called public country-by-country reporting directive (CBCR), which contains measures to enhance corporate transparency of big multinational companies. Inter-institutional negotiations with the European Parliament can now start. The proposed directive is part of the European Commission Action Plan on a fairer corporate tax system.

### ■ Fiscal Policy

The EC published its guidance for Member States on the conduct of fiscal policy in response to the coronavirus pandemic, including the implications of

the Recovery and Resilience Facility. For the Commission, the coordination of national fiscal policies is essential to support the economic recovery. The guidance also aims to facilitate Member States in the preparation of their stability and convergence programmes which shall be presented in April.

#### ■ **Brexit**

The Council requested the European Parliament’s consent to its decision on the conclusion of the EU-UK Trade and Cooperation Agreement. Once the Parliament has given its consent, the Council will adopt the decision on the conclusion of the agreement, allowing its official entry into force. The agreement has been provisionally applied since 1 January 2021.

#### ■ **Russia**

The Council decided to impose restrictive measures on four Russian individuals responsible for serious human rights violations, applying for the first time the framework of the new EU Global Human Rights Sanctions Regime which was established on 7 December 2020. The measures consist of a travel ban and asset freeze.
