■■ Online Platforms

The European Parliament published a study on online platforms, with a special focus on how to better regulate these digital markets. The document contains a series of recommendations such as the need to have tailored “codes of conduct” for online platforms; more stringent controls for mergers involving the biggest gatekeeper platforms; controls on data inferences.

■■ Cyber-security

The Council adopted its conclusions on the European Cybersecurity Strategy for the Digital Decade. EU Member States stressed the need to accelerate the uptake of key internet security standards and to support the development of strong encryption,

Council conclusions

■ Environmental Liability

The EC adopted guidelines to clarify the scope of the term “environmental damage” in the Directive 2004/35/EC on environmental liability. They aim to provide legal clarity and harmonisation of its interpretation.

■ Taxation

The Council adopted new rules to improve administrative cooperation in the field of taxation and address the challenges posed by the digital platform

economy. The new rules will apply from 1 January 2023 and will cover digital platforms located both inside and outside the Union.

■ Retail Payments Market

The Council adopted its conclusions on the Retail Payments Strategy for the EU, presented by the European Commission last September. EU countries called on the Commission to work in order to develop an EU-wide payment solutions to limit the European dependency on major global players. Legislative proposals will be adopted if necessary.

■ EU Emissions Trading System

The Energy and Climate Package that the European Commission will present in June is expected to expand the scope of the EU ETS to cover also building and road transport sectors.

■ Green Battery Proposal

Some Member States expressed concerns on the European Commission's proposal on sustainable battery, in particular on the economic and administrative burden that the new rules will impose on SMEs and on its implementation.

■■ Artificial Intelligence

The European Commission is scheduled to present its proposal on Artificial Intelligence on 21 April. According to some rumours, the European executive is considering the need to limit the use of high-risk AI applications, such as live facial recognition in public spaces.
