Merger Control

The EC published its Staff Working Document with the findings of the evaluation of procedural and jurisdictional aspects of EU merger control. As a result of this evaluation, the Commission adopted a Communication providing guidance on the application of the referral mechanism ex article 22 of the Merger Regulation.

<u>EC Staff Working Document</u> – <u>Article 22 Guidance</u>

The Commission also launched an impact assessment to explore different policy options for further simplification of merger procedures, in particular on the revision of Commission Regulation 802/2004 implementing Council Regulation 139/2004 on the control of concentrations between undertakings and the Notice on Simplified Procedure. Feedback to the

In addition the Commission published a public consultation in order to gather further information from interested parties; contributions can be sent until 18 June. A synopsis report summarizing the input received will then be published by the European executive.
