

■ Artificial Intelligence

The EC invites interested parties to submit feedback by 22 June on its proposal for a regulation on a European approach on AI adopted last week. All feedback received will be presented to the European Parliament and Council with the aim of feeding into the legislative debate.

■ Intellectual Property

The EC launched two public consultations linked to its Intellectual Property Action Plan. With the first consultation on industrial design protection, the Commission aims to obtain views of all those affected on selected issues in view of the review of the Community Design Regulation (Regulation 6/2002). The second consultation refers to EU-wide protection of geographical indications for non-agricultural products. Both consultations will remain open until 22 luly

Brexit

The European Parliament in plenary voted in favour of the EU-UK Trade and Cooperation Agreement, agreed last December. The Council also adopted a decision on the conclusion of the agreement. This is the last step in the ratification process. On 1 May the TCA will enter into force.

■ Customs Legislation

The EC calls interested parties to submit feedback until 19 July on its mid-term evaluation of the Union Customs Code, with the aim to assess to what extent it achieved its objectives.

■■ Digital Taxation

The European Parliament adopted a resolution on digital taxation. MEPs call for a minimum effective tax rate to reduce tax avoidance and prevent damaging tax competition. In the coming months the European Commission is expected to present a proposal on a digital services tax.
