## / Law

### ■ Data Act

The EC launched a public consultation on its Data Act to ensure fair access to and use of data for legitimate purposes, including in business-to-business and business-to-government situations. Contributions can be submitted until 3 September. This piece of legislation complements the Data Governance Regulation of last November.

### ■ Internal Procurement Instrument

The Council agreed its negotiating mandate on the regulation to create an International Procurement Instrument (IPI) which aims to address the lack of a level playing field in the procurement markets. Once the European Parliament has adopted its position, inter-institutional negotiations will start.
