■ EU Strategic Foresight Report

The EC adopted its second Strategic Foresight Report which presents a multidisciplinary perspective on the EU's challenges and opportunities across four strategic areas: climate change and other environmental concerns, digital hyperconnectivity and technological transformations, pressure on democracy and values, shifts in the global order and demography. The foresight will guide the Commission in the transition towards a green, digital and fair Europe. The report will also inform the Commission work programme for next year. Among the ten priorities there is securing decarbonised and affordable energy; strengthening capacity in data management; regulating artificial intelligence and cutting-edge technologies; securing and diversifying supply of critical raw materials.
