#### ■ State of the Union

The President of the European Commission delivered her State of the Union speech, stressing the importance of supporting Europe's strategic economy, building a stronger health union, investing in the green and digital transition and creating a European defence system. In the Letter of Intent submitted to the European Parliament and the Council, she outlined the actions and initiatives that the European executive intends to present in the following years. Among them there are:

- legislative proposal on carbon removal certification;
- legislative proposal on the right to repair;
- legislative proposal on an EU framework for harmonised measurement of transport and logistics emissions;

- legislative proposal to reduce the release of microplastics in the environment and to restrict the addition of microplastics to products;
- European Cyber Resilience Act;
- European Chips Act;
- roadmap on security and defence technologies;
- review of competition policy (fit for new challenges);
- legislative proposal on multimodal digital mobility services;
- legislative proposal to facilitate SMEs access to capital;
- initiative on instant payments in the EU;
- implementation of the Capital Market Union Action Plan including the Initiative on harmonising certain aspects of substantive law on insolvency proceedings;

- legislative proposal on the implementation of the OECD global agreement on minimum effective taxation.

## State of the Union speech - Letter of Intent

#### **■■** Digital Transformation

The EC presented its plan to achieve the EU's digital transformation by 2030. In particular, the Commission proposed to engage in an annual cooperation mechanism with Member States to reach the 2030 Digital Decade targets in the areas of digital infrastructures, digitalisation of businesses and public services. In addition to that, the European executive has identified an initial list of multi-country projects in data infrastructure, 5G, high-performance computing, blockchain, digital innovation hubs.

## **■■** Green Competition Policy

The EC published a policy paper setting out some clarifications on the topic of sustainability and competition law. The Commission is currently reviewing its antitrust guidelines. It also plans to adopt final guidelines on State aid for climate, energy and the environment soon.
