Anti-coercion Instrument

The EC adopted its proposal for an EU anti-coercion instrument. This framework regulation will complement the existing toolbox, providing the Commission with an additional legal instrument to use as a deterrent against economic coercion by third countries. The proposal now needs to be discussed and negotiated by the two co-legislators, the European Parliament and the Council. During the next eight weeks interested parties can submit their comments on the proposal.

■ Antitrust – Platform Work

The EC launched a consultation on the draft Guidelines on the application of EU competition law to collective agreements regarding the working conditions of solo self-employed people providing services. Contributions

can be submitted until 24 February. The Commission will then assess the comments and publish the final guidelines in the second quarter of 2022. Together with the consultation, the Commission released a proposal to improve the working conditions in platforms.

■ State Aid – Risk Finance Guidelines

The EC adopted revised Guidelines on State aid to promote risk finance investments, which will apply from 1 January 2022. Among other things, the new guidelines introduce simplified requirements for the assessment of schemes targeting start-ups and SMEs.

■ State Aid – Short-term Export Credit Insurance

The EC adopted a revised Communication on Short-term export credit insurance, which will enter into force on 1 January 2022 with some adjustment to enable Member States to provide public insurance to European exporters.

■ Data Act

The EC published the results of the public consultation on the upcoming initiative of the European Data Strategy, the so-called Data Act. The consultation ran from June to September and the contributions received will feed into the impact assessment of the legislative initiative, which is expected for February.

■ Roaming

The European Parliament and the Council reached a political agreement on the new Roaming Regulation, which will prolong until 2032 the existing system. The new regulation will enter into force on 1 July 2022.

Current Roaming Regulation

■ VAT

The Council adopted its general approach on the proposal to amend Directive 2006/112/EC as regards rates of value-added tax for goods and services. The new rules will update the list of goods and services to which all Member States can apply reduced VAT rates and remove by 2030 the possibility for Member States to apply reduced rates and exemptions. The text will now be sent to the European Parliament for its consultation. Once adopted, the new directive will come into force 20 days after its publication in the EU Official Journal.

Commission Implementing Regulation of 7 December 2021 imposing a definitive anti-dumping duty on imports of aluminium converter foil originating in the People's Republic of China has been published in the EU Official Journal.

■ Joint Technology Competition Policy Dialogue

EU Commissioner Vestager and the Head of the US Federal Trade Commission launched the Joint Technology Competition Policy Dialogue, with the aim to share insights and experiences and to strengthen coordination on policy and enforcement.

■ Wholesale of solid, liquid and gaseous fuels and related products

The EC fined Abengoa S.A. and its subsidiary Abengoa Bioenergia S.A. for participating in a cartel concerning the wholesale price formation mechanism in the European ethanol market.

■■ Alternative Fuels Infrastructure

At the Transport Council meeting of 9 December, EU Ministers held a policy debate on the draft regulation on the deployment of alternative fuels infrastructure (AFIR). In general Ministers expressed support for the objectives of the proposal, however some of them underlined the need to have more flexibility and to take account of national specificities such as population,

surface area and traffic density, instead of a one size approach. EU Ministers also underlined the importance of having accompanying measures and incentives at the beginning, without hampering private investment.

Presidency progress report

■ Resilience of Critical Entities

The Council is expected to formally adopt on 20 December the general approach on the proposal for a directive on the resilience of critical entities, paving the way for inter-institutional negotiations with the European Parliament to start. The directive aims to help strengthen the level of protection and resilience of

infrastructure that provide fundamental services for social and economic activities, updating the rules in place in light of the new challenges. The proposal covers critical entities in different sectors such as energy, transport, banking, digital infrastructure, health, waste and space.
