■ Energy and Climate

The EC published a series of proposals which are part of the Fit for 55 Package to deliver on the European Green Deal and the European Climate Law.

The Commission released two legislative proposals to decarbonise the European gas market by facilitating the use of renewable and low carbon gases, including hydrogen. Competitive markets and dedicated infrastructure to connect production and consumption are key elements of the package. Another important aspect is the security of supply; on that regard, the proposal will promote a more strategic approach to gas storage, also enabling voluntary joint procurement by Member States.

The package contains the first European proposal on methane emissions reduction in the energy sector, with provisions on measurement, reporting and verification of emissions.

The proposal for a directive on energy performance of buildings introduces several measures such as renovation passports, energy performance certificates and minimum energy performance standards to apply to all buildings with an energy label G. As of 2030 all new buildings must be zero-emission while all new public buildings must be zero-emission already from 2027.

Last but not least, the Commission also published a communication on sustainable carbon cycles, which provides short and medium actions to increase removals of carbon from the atmosphere. By the end of 2022 the Commission will propose an EU regulatory framework for the certification of carbon removals; at the same time the European executive will engage with stakeholders in order to improve sustainable non-fossil sources for chemical and plastic products by 2030.

■ Trans-European Networks for Energy

Negotiators of the European Parliament and the Council reached a provisional political agreement on the revision of the Trans-European Networks for Energy (TEN-E) Regulation. Among other things they agreed to end support for new natural gas and oil projects and to introduce mandatory sustainability criteria for all projects. The provisional agreement needs to be officially endorsed by both the Council and the European Parliament. The text will be available soon.

■■ Efficient and Green Mobility Package

The EC unveiled its Efficient and Green Mobility Package, which consists of a set of measures to modernise the European's transport system in line with the objectives of the European Green Deal in order to increase connectivity, to support the roll-out of charging points and alternative refuelling infrastructure while focusing on sustainable mobility.

The proposal for the revision of the Trans-European Transport Network (TEN-T) aims to modernise the entire network addressing the missing links. It also requires 424 major cities on the TEN-T network to develop Sustainable Urban Mobility Plans to promote zero-emission mobility by 2025. Among the novelties of the proposal there are requirements for the deployment across the TEN-T network of the charging and refuelling infrastructure needed for alternative transport fuels in line with the Alternative Fuels Infrastructure Regulation.

With the proposal for the review of the Intelligent Transport Systems Directive the EC aims to update the Directive to the emergence of new road mobility options, mobility apps and connected and automated mobility. In particular, the Commission intends to make certain crucial data (such as speed limits, traffic circulation plans, roadworks) available in digital format and to increase the interoperability of ITS applications also by expanding the scope of the directive to automated mobility. Next year the Commission will present a new initiative on multimodal digital mobility services which aims at supporting the development of digital service intermediaries.

The package also contains a framework to address new mobility challenges, including provisions on funding opportunities for local and regional authorities to implement the measures. In 2022 the Commission will present a recommendation for the development of national plans to assist cities in developing their mobility plans. In the first quarter of next year the EC will also release guidance on passenger transport-on-demand to become more sustainable. A detailed study to map and clarify which digital solutions would enable more effective and user-friendly low-emission zones and other types of urban vehicle access regulation will be conducted in 2022.

■ EU Climate Law

The EC issued guidance for a fair and inclusive transition towards climate neutrality, helping Member States to

implement the measures by addressing the relevant employment and social aspects linked to the transition.

■ Environmental Criminal Law

The EC adopted a proposal for a new Directive to repress environmental crimes. The proposal defines new crimes, sets a minimum level for sanctions and strengthens the effectiveness of law enforcement cooperation. The proposal will now be submitted to the European Parliament and the Council.

WTO and the Environment

The EC agreed on three new initiatives within the World Trade Organization, with the aim to work jointly on facilitating trade in environmental goods and services, promoting sustainable supply chains and the circular economy; enhance transparency of fossil fuel subsidies and cooperate on battling plastic pollution.

■ Digital Markets Act

The European Parliament endorsed its position on the proposal for a Digital Markets Act. Inter-institutional negotiations with the Council and representatives of the EC will start at the beginning of next year. EU lawmakers broadened the scope of the proposal including web browsers, virtual assistants and connected TV. Among other things, they adopted changes to the definition of gatekeepers based on certain thresholds and to the list of obligations and prohibitions, they added restrictions to killer acquisitions and clarified the role of national competition authorities while maintaining the EC in charge of enforcement.

■ Digital Services Act

The Internal Market and Consumer Protection of the European Parliament reached an agreement on the compromised text on the Digital Services Act, paving the way for a plenary vote in January. The DSA introduces clear responsibility and accountability rules for providers of intermediary services, in particular online platforms. Once adopted by the plenary, interinstitutional negotiations with the Council will start.

■ Digital Finance

The EC presented a new strategy to modernise financial supervisory reporting in the EU, while ensuring consistent and standardized data and facilitating the sharing and re-use of reported data amongst supervisory authorities.

■ Industrial Products

The EC launched an evaluation of the New Legislative Framework, with the aim to improve the internal market for goods by enhancing market surveillance and boosting the quality of conformity assessments. Contributions on the Commission's roadmap can be submitted until 07 March.

■ EU-India Competition

Representatives from the EU and India met on 13 and 14 December to discuss competition enforcement challenges and respective regulatory developments, in particular in digital markets and the pharmaceutical sector. In 2013 the two parties signed a Memorandum of Understanding on cooperation in the field of competition law.
