### ■ State Aid – Agriculture, Forestry and Fishery Sectors

The EC invites all interested parties to comment on the proposed revised State aid rules for the agricultural, forestry, and fishery sectors. In particular, the consultation covers the proposed revision of the 2014 Guidelines for State aid in the agricultural and forestry sectors and in rural areas, the Agricultural Block Exemption Regulation, the Guidelines for the examination of State aid to the fishery and aquaculture sector, the Fishery Block Exemption Regulation and the Fishery de minimis Regulation. Contributions can be submitted until 13 March 2022. The adoption of the revised rules is planned for the end of 2022.
