■ Waste Directive

The EC launched a consultation on the revision of the Waste Framework Directive, which will focus on prevention, separate collection, waste oils and textiles and the application of the polluter pays principle. Contributions can be submitted until 16 August.

■ Russian sanctions

The EC presented its proposals to add the violation of EU restrictive measures to the list of EU crimes and to reinforce recovery and confiscation of assets of individuals and entities violating restrictive measures.

■ Trade with Ukraine

The Council adopted a regulation to allow temporary trade liberalisation and other concessions for certain Ukrainian products for one year. In particular, all tariffs under Title IV of the Association Agreement between the EU and Ukraine establishing a deep and comprehensive free trade area that had not yet been

liberalised will be suspended. The regulation will soon be published in the EU Official Journal.

■ Cybersecurity

The Council approved its conclusions on the Union's cyber posture, which calls upon the European Commission to propose common cybersecurity requirements for connected devices and associated processes and services.

■ Capital Markets Union

The Council adopted its position on a proposed modification of the regulation on European long-term investment funds (ELTIFs), to make these investment funds more attractive. Inter-institutional negotiations with the European Parliament will start once the latter has agreed its position.
