## / Law

#### ■ International Public Procurement Instrument

The European Parliament adopted the agreement reached with the Council on the new International Procurement Instrument (IPI), which introduces measures to limit third countries companies to access the open EU public procurement markets if their governments do not offer similar access to public tenders to European companies. Now the text needs to be officially adopted by the other co-legislator, the Council. The regulation will enter into force on the 60<sup>th</sup> days after its publication in the EU Official Journal.

#### **■** Greenhouse Gas Emissions

The European Parliament adopted its position on the proposal to revise Regulation 2018/841 on the

inclusion of greenhouse gas emissions and removals from land use, land use change and forestry (LULUCF). In particular, lawmakers expressed their support to the Commission's proposal to increase EU 2030 greenhouse gas emission reduction target to 57% and proposed setting-up a natural disturbances mechanism from 2026 to 2030 for those countries that did not reach their annual targets due to natural disturbances, such as forest fires. Inter-institutional negotiations with the Council can now start.

#### **■ ETS Reform**

The European Parliament in plenary rejected the report of the Environment Committee on the revision of the EU Emissions Trading System and referred it back to the Committee in order to work on a new compromise text. The different political groups at the Parliament were

divided on the level of ambition of the report with regard to the amount of greenhouse gas emissions to reduce. Once adopted a new compromise and approved by the plenary, negotiations with the Council will start.

#### ■ Carbon Border Adjustment Mechanism

The report on the regulation establishing a Carbon Border Adjustment Mechanism was referred back to the Environment Committee by the European Parliament in plenary. The Environment Committee will meet in the coming days to discuss a way forward on the file, with the aim of adopting a new position and starting inter-institutional negotiations with the Council on a final text. Members of the Environment Committee Parliament aimed at a broader scope, in fact they wanted CBAM to cover aluminium, hydrogen, polymers and organic chemicals in addition to the products listed by the Commission in its original proposal, iron, steel, refineries, cement, organic basic chemicals and fertilisers. Lawmakers also wanted to extend CBAM to include indirect emissions.

#### ■■ CO2 Emission Standards for Cars and Vans

The European Parliament adopted its position on the proposed rules to revise the CO2 emissions performance standards for new cars and vans. Lawmakers support the Commission's proposal to reach zero-emission road mobility by 2035; intermediate reduction targets for 2030 would be set at 55% for cars and 50% for vans. EU Member States are expected to adopt their position by the end of June, then inter-institutional negotiations on a final text of the proposal will start.

#### **■** Financial Markets

The EC adopted three decisions determining that the legal and supervisory frameworks for central counterparties (CCPs) in Chile, Malaysia and Indonesia are equivalent to the requirements applicable under the European Market Infrastructure Regulation (EMIR). In addition, the Commission amended the existing equivalence decisions for CCPs from South Africa and India.

#### **■** Consumer Credit

The Council agreed its position on the proposal to review the Consumer Credit Directive of 2008. In particular, the new rules aim to promote transparent practices of all actors involved in consumer credit. As soon as the European Parliament adopts its position, inter-institutional negotiation will start.

#### **■** Common Charger

The Council and the European Parliament reached a provisional agreement on the proposal for a directive introducing a common charging port for a whole range of electronic devices. The agreement is subject to formal approval by the Council and the European Parliament. The agreed text will be available soon.

EU Ministers discussed the progress made so far on the proposal for a regulation establishing a framework of measures for strengthening Europe's semiconductor ecosystem (the so-called Chips Act), stressing the need for coordinated action at European level to resolve the current semiconductor supply crisis.
