The EC sent to Member States for consultation a draft proposal to adjust the State aid Temporary Crisis Framework adopted last March in order to support the economy in the context of the invasion of Ukraine by Russia.

■ Sanctions on Russia

The EU is working on a new package of sanctions against Russia. The package is expected to be adopted by Member States next week and shall include a ban on importing Russian gold.

Negotiators from the European Parliament and the Council held the first round of negotiations on the reform of the Emissions Trading Scheme.

■ Data Act

The Presidency of the Council released a first partial compromise text on the proposal for a Data Act, which will be discussed by Member States at the meeting of the Council working party on 19 July.
