### Law

#### **Anti-coercion Tool**

The Council approved the regulation on the protection of the Union and its Member States from economic coercion by third countries. The new law is intended to act as a deterrent but, as a last resort, the EU will be able to impose countermeasures on a third country. The regulation shall be published in the EU Official Journal by the end of November and it will enter into force 20 days after its publication.

#### **Net-Zero Industry Act**

The Industry Committee of the European Parliament adopted its draft report on the Net-Zero Industry Act. The Parliament in plenary is expected to endorse the report at its November plenary session. Interinstitutional negotiations for a final shape of the legislation will then start. The draft report will be available soon.

#### **Digital Services Act**

Amazon, LinkedIn, TikTok, Pinterest, Snapchat, Zalando and Bing have published their transparency reports, which include, among others, information concerning content moderation on the platforms' services.

#### **European Green Bonds**

The Council adopted a regulation creating a European green bond standard. The new law will also establish a registration system and supervisory framework for external reviewers of European green bonds. The regulation will soon be published in the EU's Official Journal and it will start applying 12 months after its entry into force.

#### **CO2 Emission Standards**

The Environment Committee of the European Parliament voted on the draft report on the proposal to strengthen the CO2 emission performance standards for new heavy-duty vehicles. The Parliament in plenary is expected to adopt the report during the second plenary session of November. Then inter-institutional negotiations on the final shape of the regulation will start. The draft report will be available soon.

#### **Packaging and Packaging Waste**

The Environment Committee of the European Parliament adopted its draft report on the proposal for a regulation on packaging and packaging waste which will replace the current Directive. The Parliament in plenary is expected to vote on the report during the second session of November.

#### **Right to Repair**

The Internal Market Committee of the European Parliament adopted its position on the proposal to strengthen the right to repair and promote sustainable consumption. The draft report needs to be endorsed by the Parliament in plenary, most likely at the end of November. Once the Council adopts its position, interinstitutional negotiations on the final text can begin. The draft report will be available soon.

#### **Energy Labelling**

The EC is collecting feedback on its commission implementing regulation setting requirements for the functioning of the European Product Registry for Energy Labelling (EPREL) system, managing the product database for products covered by the Labelling Regulation 2017/1369. Contributions can be submitted until 21 November.

#### **EU Customs Code**

The EC launched two initiatives to collect feedback on its initiative to adapt certain rules set out in the implementing act stemming from the Union Customs Code (UCC) to digitalize the proofs for the customs status of EU goods and clarify certain aspects of the transit procedures. Contributions can be submitted until 21 November. The second initiative relates to certain rules of the delegated regulation with the aim to simplify customs formalities for electronic cargo sensor devices and clarify rules on proof. Contributions can be submitted until 20 November.

#### Wind Power

The EC published its action plan which contains a series of measures to support the European wind power industry.

#### **Clean Technologies**

The EC adopted a communication to promote and support the development of clean technologies by reinforcing the Single Market, ensuring a level-playing field, supporting research and innovation and expanding relationships with external trade partners.

#### **Distance Contracts for Financial Services**

The Council adopted the new directive on distance contracts for financial services, which will repeal Directive 2002/65/EC. The directive will soon be published in the EU Official Journal end will enter into force on the twentieth day following its publication.

#### **Benchmarks Regulation**

The EC is collecting feedback on the revision of the Benchmark Regulation, in particular on its scope and third-country regime. Contributions can be submitted until 21 November.

#### **Intelligent Transport Systems**

The Council adopted new rules on the deployment of intelligent transport systems (ITS), which will revise and extend the scope of the 2010 directive, taking into account the latest technological developments on connected and automated mobility, on-demand mobility applications and multimodal transport. The new directive will be published in the EU Official Journal in the coming weeks and will enter into force the twentieth day after its publication. Member States will have 24 months after the entry into force to comply with the new provisions.
