# Law

# **Electrical and Electronic Equipment Waste**

Negotiators of the European Parliament, the Council and the European Commission reached a provisional political agreement on proposed amendments to EU law on the collection and management of waste from electrical and electronic equipment, which will cover a range of products such as computers, fridges and photovoltaic panels. The provisional agreement now needs to be formally adopted by both the European Parliament and the Council before it can be published in the EU Official Journal and enter into force. The agreed text will be available soon.

# **Right to Repair**

Both the Council and the European Parliament adopted their respective positions on the proposal for a directive on common rules promoting the repair of goods, which will impose new obligations on companies involved in the production, sale or repair of goods. Inter-institutional negotiations on the final version of the law can now start and a first meeting is scheduled on 7 December.

## **Packaging of Waste**

The European Parliament adopted its position on the proposed regulation on EU-wide rules on packaging and packaging waste, which will amend the current framework. In particular, the new rules require that all packaging should be recyclable, fulfilling strict criteria to be defined through secondary legislation, with certain temporary exemptions, for example for wood and wax food packaging. Inter-institutional negotiations on the final version of the regulation will start once the Council has adopted its position.

### **Net Zero Industry Act**

The European Parliament adopted its position on the proposal for a regulation on establishing a framework of measures for strengthening Europe's net-zero technology products manufacturing ecosystem, so-called Net Zero Industry Act. Once Council has also adopted its position, negotiations on the final shape of the law will start.

#### **CO2 Emission Reduction Targets**

The European Parliament adopted its amendments on the proposal for a regulation on CO2 emission performance standards for new heavy-duty vehicles, which will amend Regulation 2019/1242. Interinstitutional negotiations with the Council and the European Commission on the final shape of the legislation will soon start.

## **Certification Framework for Carbon Removals**

Both the European Parliament and the Council adopted their respective positions on the proposal for a regulation establishing the first EU-level certification framework for carbon removals. Inter-institutional negotiations on the text will soon start.

# **Labelling Fertilizing Products**

The Council adopted its position on the proposed regulation on digital labelling of EU fertilizing products, which will amend Regulation 2019/1009. Negotiations with the European Parliament on the final shape of the law will start as soon as the European Parliament adopts its position.

# **Banking Union**

The Council adopted a mandate to start negotiations with the European Parliament and the European Commission on the final version of the so-called Daisy Chains proposal, which is a targeted amendment of the Bank Recovery and Resolution Directive (BRRD) and the Single Resolution Mechanism Regulation (SRMR) with the aim to address certain issues in relation to the treatment of "internal MREL" in bank resolution groups.

#### **Artificial Intelligence Act**

Inter-institutional negotiations on the so-called Artificial Intelligence Act are currently at a standstill over a section of the draft regarding foundation models. The European Parliament intends to regulate them, while at the Council different Member States are of a different opinion. In particular, France, Germany and Italy call



for a review of that part of the law. The Presidency of the Council is working on a new compromise text before next trilogue meeting on 6 December.

## **Product Liability**

Inter-institutional negotiations on the final version of the proposed Product Liability Directive are still ongoing, next meeting is planned on 14 December.
