Heavy-Duty Vehicles

The European Parliament adopted the text of the agreement reached by the negotiators of the European Parliament, the Council and the European Commission on the proposal which will review Regulation 2019/1242 on CO2 emission standards for new heavy-duty vehicles in the EU. As part of the new rules, the Commission will have to produce an assessment methodology for the full lifecycle emissions of new heavy-duty vehicles. The Council now needs to formally approve the agreement before it can enter into force.

Sustainability Reporting Standards

The European Parliament approved the provisional agreement reached with the Council on the proposal to delay the adoption of all sector-specific sustainability reporting standards (ESRS) for EU companies and general ESRS for non-EU companies. Next step is the adoption of the text by the Council.

Industrial Emissions

The Council officially adopted the agreement reached with the European Parliament on the revised directive on industrial emissions and the regulation on the establishment of an industrial emissions portal. The directive and the regulation will soon be published in the EU Official Journal.

Carbon Removals

The European Parliament adopted the agreement reached by the negotiators on the proposal for a Union certification framework for carbon removals. The framework is a voluntary tool which will certify three types of carbon removal activity. The text now has to be adopted by the Council, then it can be published in the EU Official Journal.

Energy Performance of Buildings

The Council formally adopted the revised directive on the energy performance of buildings, which will be published in the EU Official Journal in the coming weeks. Member States will then have two years to transpose the new rules into their national legislation.

Pharmaceutical Legislation

The European Parliament adopted its position on the package to renew the E pharmaceutical legislation. The package consists of a new directive and a regulation. Inter-institutional negotiations with the Council and the European Commission on the final shape of the law will start after the European elections.

Foreign Subsidies

The EC announced a new investigation into Chinese suppliers of wind turbines in Spain, Greece, France, Romania and Bulgaria.

China - State Distortions in Economy

The EC published a report on significant state-induced distortions in the economy of the People's Republic of China. The document is an update of the 2017 report and provides factual information for ongoing and future antidumping investigations. Compared to the previous text, green and high-tech sectors have been added to the list.

Sanctions

The Council officially adopted the directive on the definition of criminal offences and penalties for the violation of Union restrictive measures and the directive on asset recovery and confiscation, which will set out European minimum rules on the tracing, identification, freezing, confiscation and management of criminal property. The two legal texts will soon be published in the EU Official Journal and will enter into force on the twentieth day following their publication.

Trade - Ukraine

Negotiators of the European Parliament and the Council reached an agreement on the renewal of trade liberalization measures with Ukraine, the so-called Autonomous Trade Measures initially introduced in 2022. The suspension of import duties and quotas on Ukrainian exports to the EU will last until 5 June 2025. The deal now needs to be formally adopted by both the European Parliament and the Council. The text of the agreement will be available soon.
